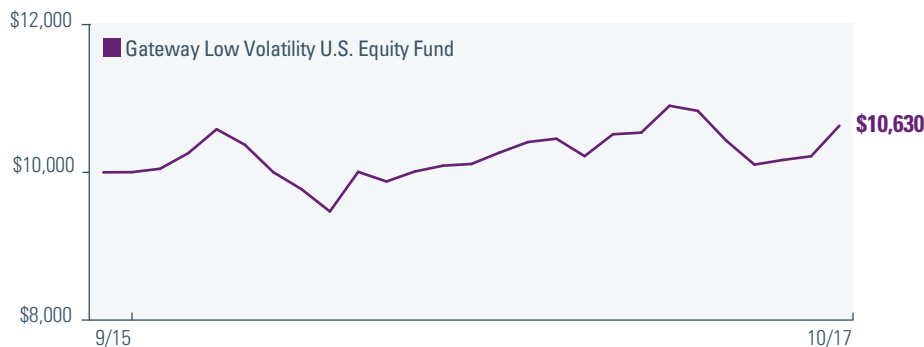
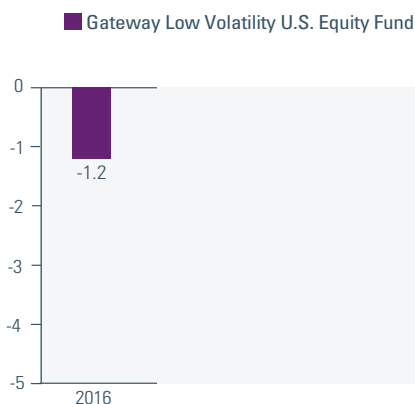

FUND HIGHLIGHTS

- A low-volatility equity fund that seeks to capture the majority of the returns associated with equity markets while exposing investors to less risk than other equity investments
- Invests in a broadly diversified portfolio of U.S. equity securities that track the U.S. equity market, while using index call and put options to reduce the volatility of the portfolio and generate income
- Potential to enhance the risk-adjusted returns for many portfolios due to its attractive risk/return profile
- Consistent and attractive cash flow from options strategy creates potential for better long-term risk-adjusted returns than equity markets

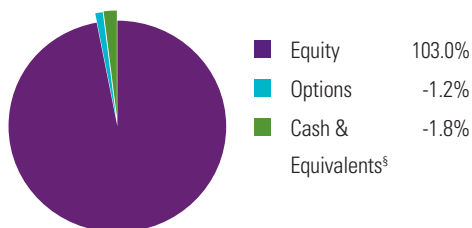

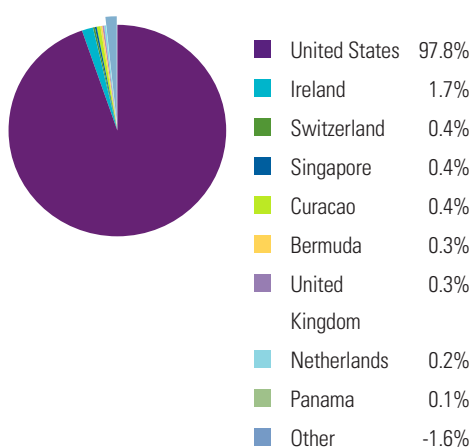
